## Purpose of the Role

The key purpose of this role is to provide instrumental music instruction and ensemble direction to violin students at Southern Cross Grammar.

## Key Aspects of the Role

- Plan and deliver high quality Violin instruction to students across a range of year levels and abilities
- Provide ensemble direction within the String Program
- Facilitation and direction of the Year 2 Strings Program
- Arrange Violin lesson timetables
- Manage the administrative tasks associated with undertaking the role of an Instrumental Music
  Instructor
- Prepare students for performances at key school events including music recitals, concerts, presentation evenings and assemblies
- Prepare students for and facilitate internal and external AMEB music examinations
- Contribute to and participate in the overall musical life of the school, and assist where required with the planning and conduct of music within the school community
- Maintain accurate records of student attendance, performances and progress
- Assist and contribute to the planning of public performances, workshops and camps
- Attend non-student days such as school planning and professional development days.

#### Student Care

- Encourage a positive environment, where achievements are celebrated, each student feels valued, and a sense of belonging and connectedness is created for all
- Model authentic and meaningful conversations with members of our community adopting a restorative approach in addressing issues of conflict as required
- Collaborate with Heads of Year Level, Head of Learning Enhancement and Diversity, Student Counsellor and other teachers to ensure the support of students with additional needs and/or at-risk students.

#### **Communication and Connection**

- Form strong collaborative relationships with students, colleagues, parents and the broader school community focused on student learning, agency, wellbeing and engagement
- Regularly communicate with parents/guardians to assist them in supporting their child's academic growth and wellbeing
- Work closely with colleagues in the provision of a challenging, balanced, relevant and differentiated curriculum for students across programs
- Actively build professional networks with key external partners and professional associations
